FOR THE ATTENTION OF THE PARENTS

The School is opened to all boys and girls irrespective of caste, creed or social status subject to the availability of seats. The Medium of Instruction of the School is English.

A child seeking admission to the school must first get his/her name registered. It must not be presumed that a child who is registered for the admission will automatically be admitted.

1. After registration, the child will have to face admission test/interview. The date of the test can be ascertained from the school. The result of the test will be put up on the notice board.
2. A Pupil coming from a recognised school must produce the School leaving Certificate duly counter-signed by the concerned authority at the time of seeking admission. Municipal Birth Certificate or a Certificate from hospital signed by C.M.O. is essential for others.
3. A Child selected for admission must pay the fees within two days of notification of the result on the school notice board. If dues are not paid within two days, the admission stands automatically cancelled.
4. Children must be fit if they are to derive maximum benefits from various activities of the school. They will, therefore, be subjected to medical fitness/Examination.
5. The admission of the child to the school will mean a complete acceptance by the parents/guardian of all rules as are in force or as are amended from time to time.
6. The principal reserves the right to refuse admission to any child without furnishing any reason.
7. Student will be given provisional admission subject to medical fitness & other necessary formalities
8. Van Facility is limited. School is not abide to provide van facility to everyone admitted here.
